RESPONSE TO QUERY REGARDING TRADING ACTIVITY

The Board of Directors of SATS Ltd. (the “**Company**” or “**SATS**”) refers to the queries from Singapore Exchange Securities Trading Limited (“**SGX-ST**”) on 16 December 2016 regarding the unusual price movements in the shares of the Company on 16 December 2016 (the “**Queries**”) and wishes to respond to the Queries as follows:
